Achievements and performance

Summary of the main achievements of the charity during the financial period	For the first half of the period the Shed had to continue precautions imposed by the Covid pandemic and was unable to meet. There continued remote contact via social media and interaction with other sheds and organisations The board resolved to continue to pursue a Community Asset Transfer application to purchase the former Walston Primary School. This proved to be very difficult, not only because of Covid but also due to South Lanarkshire Council (SLC) having a different understanding of the legislation. As we could see no prospect of bringing our application to fruition within a reasonable timescale we put pressure on SLC via elected representatives and this resulted in us being offered a ten year lease on the property. This was accepted as an interim measure and we took over the building on the 22nd October 2021. On taking up the lease we had great difficulty organising services as we had no handover information other than the alarm code. This resulted in initially very high electricity bills. Fortunately we were helped out by Biggar Bridge Club who paid half the amount. We restarted meetings in September packing up and preparing for the move then setting up in our new premises. We were fortunate to benefit from a number of grants from various bodies as well as donations of different kinds from individuals and local businesses. It was gratifying to see so many members brave the uncomfortable conditions to get the Shed up and running. In very challenging circumstances we were able to provide the charitable outcomes envisaged in our constitution. During the period our membership increased from 21 to 33.
